TOPIC II - MPO Boundary Adjustment

TOPIC III - Transit Report

Ms. Gresham gave a brief report on transit activities as follows:

- The decrease in the FY14/15 due to the Transit Development Plan(TDP) \$75k not being included. The TDP is scheduled to be completed Dec. 2014
- New changes to our Transit Route System, a change has been added to the Silver Line to include a bus near WGL
- Proposed Fare Increase Effective July 1, 2014, the base fare will change from \$1.25 to \$1.50, and increase \$0.05 for the next four years

Continuous review of our existing routes to determines ways to increase efficiency

Mr. Breedlove gave an update of DOT projects currently in the area.

TOPIC V – Airport Report

Ms. Aehle gave a brief update noting that work should soon begin as the funds are available for the demolition of the old building and resurfacing current parking lot and air pad parking ramp behind new terminal.

Mr. Forgey and members briefly discussed a rising interest in solar farms.

TOPIC VI – City of Leesburg Members

Mr. Alexander introduced Jim Quinn, City of Leesburg Mayor. Mr. Alexander noted the DARTS program has been beneficial to Leesburg, a town of 3,000 that increases to 10,000 everyday due to the school being inside the city limits. He stated over the years the traffic congestion situation has been helped through DARTS by utilizing the UPWP to create a downtown master plan for which the city will now apply for transportation enhancement funds when they become available; this will take parking off the street and gives an opportunity to enhance the area. He noted the north bypass is under construction, including a bridge over US 19 and the railroad tracks and ask everyone to come and join the Governor on May 8 in Leesburg for ground breaking.

Ms. Newton stated the by-laws would have to be changed and added certain positions could be recommended as members to the committees.

Mr. Alexander stated he would like to recommend the following Leesburg officials to be members on the following committees:

- Technicial Coordinating Committee: William Clark, Director of Public Works
- DARTS Policy Committee: Jim Quinn, City of Leesburg Mayor; and Bob Alexander, Leesburg City Manager

A motion was made by Mr. Maples to recommend forwarding the following to the Policy Committee as appointed members: William Clark, Leesburg Public Works Director to the Technical Coordinating Committee; Jim Quinn and Bob Alexander to Darts Policy Committee.
