**TOPIC III**

Lee Burner was present to give the Transit Report. He stated that they were working on the COA, Comprehensive Operation Analysis, to have a complete concept of the transportation systems and what areas may need improvement or what areas there may be anticipated increases needed for services and/or new buses. There have also been discussions for plans to rehabilitate the facilities.

**TOPIC IV**

Randy Casagrande distributed the Topics Report and reported that there was nothing new to update.

**TOPIC V**

LtCol Don Finn, Fred Broome, P.E., and Hubert Smigelski from the Installation and Environment Division of USMC were present to brief the committee on the traffic flow in and out of the gates and the Mock Road gate project. Mr. Finn reported the total number of vehicles entering and exiting MCLB Albany daily, Monday through Friday, included all the gates – the main gate, truck gate, and Johnson Road gate. He noted that the count included all cars and trucks. He also stated that the Mock Road gate project relocates the truck inspection area from Fleming Road truck gate to the Mock Road gate. The estimated cost is \$750K and would require six to nine months to construct. The purpose of the project would be to eliminate the collision hazard associated with trucks parked along Fleming Road as they await inspection.
