Engineering Reports

City of Albany – Ken Breedlove

Looking into installing a new traffic signal at Broad and Broadway. Traffic signal at Westover and Oakridge has been completed. Traffic signal at Clark and Turner Field will be upgraded. Working on DOT traffic signal timing project for 48 traffic signals. Six speed tables are to be installed across the city. Currently entering phase iv of street resurfacing. Earmarked funds have been requested and waiting approval from the House in the Senate.

Dougherty County – Jeremy Brown

Completed full depth reclamation on Forester and Birchwood. Thomas Road and Morgan Road are next. In the process of completing the documents to bid out the 2021 LMIQ. Our phase 1 alleys are almost complete. 5 additional alleys were bid out on June 16th. Improvement of 8 low use alleys has been completed. An RFP will hopefully be put out for the widening of Fleming Road.

Lee County - Rozanne Braswell

Glendale subdivision is projected to be completed in August of 2021. A notice to proceed with the Pheasant Drive extension will be sent once the utility realignment has been completed.

City of Leesburg Bob Alexander

Currently continuing with the Southeastern Consultant on the concept phase of the TAP project. Currently, in the design phase of a LMIQ safety projects on US Highway 19. All these projects are matching funds using TSPLOST with the DOT.
