Amendment 1 - The FY 2024-247 Transportation Improvement Program (TIP) and 2045 Metropolitan Transportation Plan (MTP) is amended to increase Construction (CST) cost of PI# 0013992 SR 520 BU @ FLINT RIVER IN ALBANY from \$17,643,727 to \$23,530,568.53
